


Getting started with DC400


(1) Push a finger through an opening at the base of the DC400 to slightly tilt up the camera.




(2) Lift the other side of the arm, then pull and flip the camera head in the sequence and direction indicated by arrows below.




(3) Adjust the camera head until it is horizontal to the shooting surface. Fully extend the arm to capture maximum shooting area of A3.



(4) Plug in USB cable and attach the cable organizer to the arm.



(5) While using DC400 as a webcam, long press the AF button to rotate the image.

- ·Be careful not to pinch your fingers when moving the arm.
- •Do not hold the arm or camera head when carrying the product.
- ·Avoid any impact to the camera head.
